Independent Auditor's Report to the Members of the Darwin Triathlon Club

I have audited the accompanying special purpose financial report of the Darwin Triathlon Club which comprises the statement of financial performance for the year ended 30 June 2016 and the statement of financial position as at 30 June 2016.

DARWIN TRIATHLON CLUB NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2016

1. SUMMARY OF ACCOUNTING POLICIES

The accounting policies adopted by the Association are stated in order to assist in a general understanding of the financial statements. These policies have been consistently applied except as otherwise indicated.

Reporting entity

The Association is not a reporting entity because in the Committee's opinion there are unlikely to exist users who are able to command the preparation of reports tailored so as to satisfy all of their information needs, and these accounts are therefore "special purpose accounts' that have been prepared solely to meet the requirement of the Constitution and the Associations Act.

Accounting policies

The financial report has been prepared under the historical cost conventions and does not take into account changing money values except to the extent that they are reflected in the revaluation of certain assets.

In order for the financial report to present fairly the state of affairs of the Association and the results of the Association for the year, Australian Accounting Standards have been adopted to the extend disclosed in this note.

Income tax

The Association if of the opinion that it is not subject to income tax.

Other

In the 2015-16 financial year the Association continued to account for income and expenses on an accrual basis.

Grant money from the NT Government of \$17,900.00 was received in 2015-2016 for the purchase or new bike racks and trailer. As at 30 June 2016 the DTC has spent to date \$13,210.68 on the bike racks, the balance of \$4,689.32 to go towards the purchase of the trailer is shown as unearned revenue and will be moved to the profit and loss once the cost of the trailer has been incurred.

It is noted that there is an outstanding debtor in 90+ days - Darwin Cycling Club for \$500. It has been confirmed by the President of the DTC and the President of the Darwin Cycling Club that this invoice will be paid in the 2016-2017 financial year.
