Audited financial statements were circulated by Treasurer Leanne Fidler prior to the meeting.

"Treasurer's Financial Report - 2018"

We are happy to report the Club has returned a marginal profit of \$4,446.30 this year as opposed to a loss in the prior year.

The profit is a great result as we experienced a significant downturn in membership for the year. This has been somewhat offset with high participation numbers at our Come & Tri and non-member events which boosted race entry revenue. Race costs increased also as a result of increased number of events and higher entrant numbers.

Equipment and extraordinary purchases made during the year includes;

- Junior racks,
- Medal Replenishment,
- Timing Chip Stock,
- and 50% payment towards the new website (which we hope everyone has now checked out).

We are financially stable and our cash reserves increased from \$79,733 in 2017 to \$85,811 at the end of 2018.

The accounts have been audited and the signed audit and financial report for 2018 is available to all members and will be published on the website shortly.

We thank everyone for their membership and their loyalty. The financial aim of the Club is to provide members with safe, well run, regular events at minimal cost. We were happy to announce again this year that our membership fee remains unchanged (I believe it hasn't increased for at least the past 5 years) This, as well as our very cheap race entry fees being maintained, is the envy of our southern counterparts.
